## HOW DOES THE REGULATION OF LETTING AGENTS AFFECT YOU?

From January 2018 all those managing and supervising the day-to-day running of your letting agency work need to be on the Scottish Government's Letting Agent Register and inclusion requires a qualification.

The Level 6 Technical Award in Residential Letting & Property Management is one of only two qualifications currently accepted by the Scottish Government.

This established qualification is the foundation for many experienced agents in Scotland.
